Aging In Place - Mitigating Falls

Referring to a golf euphemism, 'the back nine' is often used to describe the journey to the end of the game, the last chance to improve one's score and reach the 18th hole satisfactorily. Lots of things can happen along the way, e.g. your ball goes in the water, it hits a tree and in my case, just disappears! In order to mitigate those factors causing an undesirable outcome, golfers may practice their shots at the driving range, use equipment that will enhance their skills and be optimistic that just being out in the fresh air has been a positive experience! Taking this anecdote one step further, what do we do to promote a healthy risk free day as we go about our daily activities in 'the back nine' of our lives? If aging in place refers to living safely and independently, then how can we mitigate risks?

Falls are one of the main causes of injury and loss of independence in people ages 65 and older. There are many reasons older people fall. They may lose their footing when stepping off a street curb or they may fall after getting dizzy from taking medicines. Some falls may be related to the effects of aging, such as muscle weakness or delayed reflexes. One out of every five falls causes an injury, like broken bones or a head injury. Ninety-five percent of hip fractures are caused by falling – usually by falling sideways. Women fall more often than men and account for three-quarters of all hip fractures. In a previous article, I talked about what we can do in our homes to prevent trip hazards e.g. remove throw rugs, move furniture and electrical cords to keep them out of walking paths, keep your house well lit, especially stairways, porches and outside walkways and use night-lights in areas such as hallways and washrooms. Just like the golfer who practises to control where her ball goes, we need to practise getting up from a fall. If you're unsteady, have someone with you when you practise. If you're able to get up without help, practise this once a week or often enough to feel comfortable. If you can't get up by



yourself, see a physiotherapist for help who can work with you to prevent falls and make a plan for what you can do if you do fall.

To reduce your risk of falling when you're outdoors, keep your hands free by using a cross-body shoulder bag, a fanny pack or a backpack. Watch your stepif you wear bifocal or trifocal glasses, you may have problems as you step off curbs or climb stairs. See about getting glasses with a single prescription that you can wear when you walk.

Four Things You Can Do to Prevent Falls:

- 1. Speak up. Talk openly with your healthcare provider about falls risks and prevention. Ask your doctor or pharmacist to review your medicines.
- 2. Get an annual eye and foot exam. Replace eyeglasses and footwear as needed.
- 3. Make your home safer. Remove clutter and tripping hazards. Use/install assistive devices e.g. handrails, non-slip treads, grab bars, raised toilet seat as needed.
- 4. Keep moving. Begin/continue an exercise program to improve your leg strength and balance

which will lower your chances of falling. It also helps you feel better and more confident. An example of this kind of exercise is Tai Chi. Lack of exercise leads to weakness and increases your chances of falling.

Here is a simple exercise to help improve thigh and buttock strength and to reduce fall risk.

Goal: To do this exercise without using your hands as you become stronger. How to do it:

Sit toward the front of a sturdy chair with your knees bent and feet flat on the floor, shoulder-width apart.

Rest your hands lightly on the seat on either side of you, keeping your back and neck straight, and chest slightly forward. Breathe in slowly. Lean forward and feel your weight on the front of your feet.

Breathe out, and slowly stand up, using your hands as little as possible.

Pause for a full breath in and out.

Breathe in as you slowly sit down. Do not let yourself collapse back down into the chair. Rather, control your lowering as much as possible.

Breathe out. Repeat 10-15 times. If this number is too hard for you when you first start practising

this exercise, begin with fewer and work up to this number. Rest for a minute, then do a final set of 10-15.

Finally, if you fall, do this:

- · Breath. Take several deep breaths to try to relax. Remain still on the floor or ground for a few moments. This will help you get over the shock of falling.
- · Decide if you are hurt. Getting up too quickly or the wrong way could make an injury worse.
- · Crawl to a sturdy chair. If you think you can get up safely without help, roll over onto your side. Rest again while your body and blood pressure adjust. Slowly get up on your hands and knees.
- Put your hands on the chair seat and slide one foot forward so that it's flat on the floor. Keep the other leg bent so the knee is on the floor. From this kneeling position, slowly rise and turn your body to sit in the chair.
- · Get help. If you are hurt or cannot get up on your own, ask someone for help or call 911.


Membership

Insurance Matters

We're deep into winter but greatly anticipating spring's arrival. The return of red-winged blackbirds are my harbingers of spring and now I begin to watch for them eagerly. Just a few more weeks of snow and biting cold before winter's grip begins to loosen, the soil begins to thaw and soon my tulip bulbs will begin to push green to the surface. It rejuvenates the spirit to see these signs of spring.

I thought for this issue of Connections I'd share some common questions I get from members that I hope will prove helpful for you. A question I am regularly asked is, "How long do I have until I can submit my claim? Do I have to submit right away or is there a time limit?". Claims must be received by Manulife within 12 months of the date the expense was incurred, the hospitalization or bone fracture occurred. So, if you fractured a bone March 3, 2023 you have until March 3, 2024 to submit your claim.

Another common question is about the Prior Authorization Form. This form is available on the RWTO website (www.rwto.org/membership/ insurance-plan) and is required when a member needs to make use of the Home Nursing Benefit. This form is a generic form provided by Manulife and while it states that it is for "home care, hearing aids, nursing, orthotics, prosthetic appliances, medical equipment and supplies" the only benefit in our plan that requires this form is the Home Nursing Benefit. It is not required for our Hearing Aid, Special Equipment, Mobility Assistance or Assistive Devices benefits. If a member urgently requires Home Nursing, verbal approval can be obtained by calling Manulife at 1-800-222-7340.

Members often wonder how to coordinate benefits between plans when they have coverage through RTO-ERO or OTIP. When another plan also provides coverage for the same benefit (for example, Physiotherapy), the member would first submit her claim to her primary insurer (RTO-ERO, OTIP, or a spousal employer plan). When the claim is paid by her primary insurer, she would then submit her claim to Manulife through the Hospital & Home Care Plan. Instead of submitting receipts to Manulife, she would submit the Claim Summary which shows

the amount submitted and paid by the primary insurer. The Hospital & Home Care Plan would then pay any outstanding amount to the benefit maximum. In the example provided, the member would have an additional \$200 available to her for Physiotherapy under the Hospital & Home Care Plan.

Finally, a reminder that tax season is quickly approaching, and Manulife will be making tax receipts for the Hospital & Home Care Plan available to members. If you have changed your address in the past year, please make sure Manulife is informed of your new address to ensure you receive your tax receipt. If you have registered on Manulife's SecureServe site you can now download your tax receipt from your SecureServe account. Manulife's Customer Service can be reached at 1-877-222-7340.

Resolution #1

Submitted by Area 12 (Lydia Snow North Halton, Mississauga, BurlOak, Peel North), Area 7 (Belleville, Durham North, Northumberland-South Durham, Peterborough, Trenton & District), Hamilton-Wentworth, Wiarton, South Bruce Be it resolved that Constitution, Article III Membership and Fees,

1. Regular Members: any retired woman teacher is eligible to be a member of RWTO/OERO whether or not she is receiving a teacher's pension, be amended to read:

1. Regular Members

- a. Regular Members include Retired Women Educational Professionals who have worked in schools as listed:
 - i. Retired Women Teachers

ii. Retired Women Educational Assistants

b. Retired Women Educational Professionals may become Regular Members whether or not they are receiving a job-related pension.

- The Ad Hoc Committee Report on the Survey of Membership Extension (on the website) received a substantial majority for Retired Women Educational
- · Teachers and other Educational Professionals worked as a team in the classroom and school setting with common goals for children. They supported students with different levels of abilities, behavioural issues, mobility and language challenges, and social/ emotional struggles.

· Qualification requirements for Educational Professionals have changed greatly over the years. They have received credentials, diplomas and/or certification within their areas of expertise that have

taken years of training.

 Expanding membership is particularly important for small and rural branches. Provincially, membership is both declining and aging, which can be a factor in having viable branches and filling executive roles. Membership recruitment is needed to ensure a strong organization in the future.

· Building a viable and inclusive membership would permit us to continue providing Health Care Insurance plans, combating isolation concerns for our membership, and fulfilling our goal of providing caring and sharing opportunities for women and children in our communities as well as ourselves.

Be it resolved to extend RWTO/OERO membership to include Retired Women Educational Professionals as members of RWTO/OERO. Retired Women Educational Professionals shall include but not be limited to Retired Women Teachers, Retired Women Educational Assistants, Retired Early Childhood Educators, Retired Women Speech and Language Therapists and Pathologists, Retired Women Child and Youth Workers/Counsellors and Retired Women Social Workers.

Rationale:

It is time to expand membership to all retired women who have worked in the education system. While there may be differences in qualifications and experience it is important to give all retired women who have worked in the school system the opportunity to be members of RWTO/OERO.

Resolution #7

Submitted by Hamilton-Wentworth Be it resolved that Constitution, Article I Name "The organization shall be called the "Retired Women Teachers of Ontario/Organisation des enseignantes retraitées de l'Ontario", hereafter referred to as RWTO/OERO." be amended to read: "This organization, which as of June 2023 extended its membership to represent not only Retired Women Teachers but also other Retired Women Educational Professionals, shall maintain the name "Retired Women Teachers of Ontario/Organisation des enseignantes retraitées de l'Ontario", hereafter referred to as RWTO/OERO."

Rationale:

• This has historically been the name of our organization since 1999, is well recognized throughout our communities, and maintains our identity and outstanding reputation.

· Following the positive response to the Ad Hoc Committee Report on the Survey of Membership Extension (May 2021) the Board of Directors passed Motion #74, recommending that the RWTO/OERO name remain the same.

· Adding the year the membership was expanded, gives an easily found historical reference.

Resolution #8

Submitted by Hamilton-Wentworth Be it resolved that Constitution, MISSION STATEMENT, VISION STATEMENT 1, 2 and 5, and GOALS 1, "teachers" be amended to read "Educational Professionals".

Rationale:

The word "teachers" appears 8 times in the Constitution. Two of these are used as part of our official name, which would remain the same. The other 6 are in reference to our members being Retired Women Teachers. These references now need

to be inclusive for all of our members, and Retired Women Educational Professionals incorporates everyone.

Resolution #9

Submitted by Hamilton-Wentworth Be it resolved that Constitution, GOALS 2, "retired teachers" be amended to read: "retired women educational professionals".

Rationale:

· In addition to the rationale from Resolution 8, the word "women" should be included in GOALS 2 as a better reflection of our membership, as the historical intent of this sentence was always directed to our membership of women.

• The phrase "retired women educational professionals" would now be consistent throughout the Constitution when referring to our membership.

Resolution #10

Submitted by Area 12 (Lydia Snow North Halton, Mississauga, BurlOak, Peel North), Area 7 (Belleville, Durham North, Northumberland-South Durham, Peterborough, Trenton & District) Hamilton-Wentworth, Wiarton, and South Bruce

Be it resolved that Policies and Procedures, ARTICLE III, MEMBERSHIP AND FEES,

1. Membership

- a. To be a member of RWTO/OERO, a retired woman member must pay her Provincial fees.
- b. A retired woman member may join at any time during the year.
- c. A retired woman member holds membership in the Branch to which she pays her Provincial fees.
- d. She is eligible to serve on the Executive of that Branch and/or be a delegate of that Branch.

Be amended to read:

- 1. Regular Membership to include other Retired Women Professional Educators into our organization as follows:
 - a. To be a member of RWTO/OERO, a Retired Woman Professional Educator must pay her Provincial Membership Fee.
 - b. A Retired Woman Professional Educator may join at any time during the year.
 - c. A Retired Woman Professional Educator holds membership in the Branch to which she pays her Provincial fees.
 - d. All members will have equal opportunity within the organization the Branch and Provincial levels, and/or be a delegate of the Branch.
 - e. Insurance Programs will be available to all joining women members.





Rationale:

• The replacement of "teacher" with "Woman Educational Professional" aligns the Policies and Procedures with Constitution.

• These additional statements in Policy and Procedures provide equal opportunities and supplemental insurance, if qualified, for all members.

Resolution #11

Submitted by Area 12 (BurlOak, Lydia Snow North Halton, Mississauga, Peel North)
Be it resolved that Policies and Procedures, ARTICLE III. MEMBERSHIP AND FEES,

1. Membership

- a. To be a member of RWTO/OERO, a retired teacher must pay her Provincial fees.
- b. A retired woman teacher may join at any time during the year. (Revised October 2016)
- c. A retired woman teacher holds membership in the Branch to which she pays her Provincial fees. She is eligible to serve on the Executive of that branch and/or be a delegate of that Branch. (Revised October 2016)"
- d. In addition, a member may pay a local Branch fee to other branches where she wishes to attend. (Revised October 2016)
- e. RWTO/OERO will provide Branches with a free membership pin for each new member. (Revised October 2016)

be amended to read:

- a. To be a member of RWTO/OERO, a Retired Woman Educational Professional must pay her Provincial membership fee.
- b. A Retired Woman Educational Professional may join at any time during the year.
- c. A Retired Woman Educational Professional holds membership in the Branch to which she pays her Provincial membership fee.
- d. Each member has equal opportunity within the organization, at Branch and Provincial levels, and may be a Convention delegate for their Branch.
- e. The Insurance Program will be available to any qualified member.
- f. In addition, a member may pay a local Branch fee to other Branches where she wishes to attend.
- g. RWTO/OERO will provide Branches with a free membership pin for each new member.

Rationale

- The replacement of "teacher" with "Retired Woman Educational Professional" aligns the Policies and Procedures with the Constitution.
- · Statements "d. & e." provide equal opportunities and supplemental insurance, if qualified, for all

members.

Submitted by Hamilton-Wentworth, South Bruce Be it resolved that Constitution, Article III Membership and Fees, 4. Interim Member (a.), "An Interim Member shall be a woman teacher who is currently on Long Term Disability (LTD)" be amended to read:

"An Interim Member shall be a Woman Educational Professional who is currently on Long Term Disability (LTD)".

Rationale:

· "Woman Teacher" in this statement refers to a person who has not yet retired.

* "Woman Educational Professional" would reflect our new membership status.

Resolution #13

Submitted by Area 7 Branches (Belleville, Durham North, Northumberland – South Durham, Peterborough, Trenton & District)
Be it resolved that Constitution Article X Annual Meeting 3. Definitions b) Eligible Delegates Eligible delegates who may attend the Convention are based on paid membership numbers for each Branch, be replaced with:
Each Branch shall be represented by two (2)

Each Branch shall be represented by two (2) delegates, one Provincial Delegate and one Branch Delegate, regardless of the paid membership numbers for each Branch.

Rationale:

· It is an equitable voting strategy for all Branches. Currently a Branch may have between one and seven voting delegates according to the current formula. (See AGM Report June 2022 --- the committee summarized numbers of paid-up members reported

in the Annual Area Reports)

3. Definitions (b). Eligible Delegates

So, 36 branches get 51.30% of the total votes while only 12 branches get 48.70% of the total number of votes

- · The main purpose of the Convention is an Annual General Meeting. Having only two delegates for each Branch is an efficient way to vote.
- The role of the Programme Coordinator may be easier regarding tabulation of the number of votes and calculating percentages in order to decide if a motion is carried.
- · It would be cost efficient for Branches. Provincial would continue to pay for the Convention package, including Executive registration, accommodation and mileage for the Provincial Delegate as described in the Constitution Article X Annual Meeting #6. Delegate Expenses. Provincial will continue to pay the registration fee of the Branch Delegate. Branch Delegates additional expenses of accommodation and mileage may be paid by each Branch as determined by each Branch.

There are a few new technologies that you may want to explore, as a genealogist and retired teacher I was excited about both of them.

The first is a change in the information that gets put on tombstones. You can now add a QR Code that enables anyone who visit the site to upload the code and get relevant information about your family member.



The Qr Code is embedded on to a tombstone. It contains files about the deceased person. It can have media files such as images, videos and audio files. You can also add external links to websites and family trees located on the internet. You can write a short epitaph or detailed biography of a person or a pet. You can specify a place on a map and add additional relatives. You can make the page password protected if you want but that limits who can access the files. All generated QR codes will work forever, do not expire and have no scanning limits. The first couple of QR codes I am going to work on are the one that is being placed on my parent's headstone and the next is going on my

maternal grandmother's stone. I know so much more about my grandmother thanks to my family tree and DNA.

The second is Artificial Intelligence, I am still playing with this one but the outcomes are interesting. There are several platforms to chose from, I have selected to try the free ChatGPT. As a genealogist I help other people with their family tree. In one tree the men appear to be ship builders, riveters specifically. I went on the ChatGPT and asked it to outline the history of ship building beginning in 1850. I asked that it include the cities of Glasgow and Belfast in the feedback. Instantly I got a few paragraphs of well written information on the ship building industry. I downloaded the information and uploaded it to the family tree, it helped to explain the immigration pattern that existed in the tree.

AL has been used in the Genealogy companies to generate information, Ancestry uses one to generate thrulines which develops a set of DNA assumptions. ChatGPT is a chatbot developed by OpenAI and launched in November 2022. It is built on top of OpenAI's GPT-3 family of large language models and has been fine-tuned using both supervised and reinforcement learning techniques. Wikipedia
