SESSION 1 – JUNE 8, 2011

Membership Report: Annalee Ladouceur stated that the Membership Matters Incentive Grant has resulted in new members and in a renewal of energy and enthusiasm towards programs and outreach. She thanked both Jean Axcell, as the author of the original Membership Proposal, and Carole Watson, for taking on this project.

Insurance: Anne Graham reported on the success of the Open Enrolment Insurance Campaign. She introduced Terry Kennedy, our Agent of Record, and thanked her for her hard work and dedication to our RWTO Insurance Plan. Terry presented a profit sharing cheque in the amount of \$36,430.82 to our organization. This is the largest profit sharing amount to date.
